**SECTION 4. FIRST AID MEASURES**

- If inhaled : Move to fresh air in case of accidental inhalation of vapours. Oxygen or artificial respiration if needed. Call a physician or poison control centre immediately.

**SECTION 6. ACCIDENTAL RELEASE MEASURES**

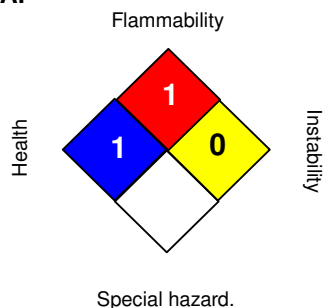
